#### **ESSENTIAL FUNCTIONS**

- 1. Regular attendance.
- 2. Work hours for supervision of students: After school: Thursday 3:30 p.m. 5:00 p.m.
- 3. Supervise students according to guidelines and standards set by the school.
- 4. Supervise children closely outside on the playground and inside the designated After school care areas. Always know whereabouts of all students at all times.
- 5. Maintain supervisor: student ratio at 1: 15.
- 6. Manage disciplinary issues with the approval of the administration.
- 7. Administer First Aid as needed.
- 8. Communicate with parents in a timely manner in reporting any student issues that occurred during after school care, including injuries and discipline issues.
- 9. Responsible for proper handover of children, relevant information, and belongings to parents and/or other after school personnel.
- 10. Provide appropriate support during emergencies.
- 11. Refrain from discussing confidential or sensitive information with unauthorized persons.

- 12. Manifest high regard for the school in grooming, demeanor, and use of social media in all its forms.
- 13. Represent the Seventh-day Adventist Church in a positive manner.
- 14. Evidence of physical and emotional health required for working with children.
- 15. Participate in required CPR, AED, and First Aid certification.
- 16. Comply with policies and procedures of SCC, including but not limited to those in the Employee Handbook, and the North American Division Working Policy.
- 17. Perform other duties as assigned.
- 18. Refrain from talking on a cell phone, texting, or using a cell phone unless absolutely necessary so as not to be distracted when supervising students.
- 19. Make sure that any students participating in sports or a specific after school program are entered into after school care.
- 20. Clean up spills or sweep isolated areas of trash on the ground when necessary.
- 21. Demonstrate professional loyalty in observing school's policies and regulations.
- 22. Comply with policies and procedures of Southern California Conference, including but not limited to those in the employee handbook, and the North American Division Working Policy.
- 23. Perform other duties as assigned.
